(A) Eligibility Criteria (as on 01st November, 2018)

(i) Qualification:

a) Doctor MBBS / BDS – Holding Valid Degree

or

b) Nurse - Holding Valid Degree / Diploma in Nursing

(ii) Age Limit: (as on 01st November, 2018)

Candidate should not be more than 30 years of age as on 01.11.2018. (Relaxation of age of 5 years for SC/ST candidates and 3 years for OBC Candidates).

(B) Emoluments: Rs.20,000/-per month with annual increase of Rs.200/-.

(C) Selection Procedure:

Candidates who fulfill the above eligibility criteria will be required to **Walk-In** for Personal Interview at the time and venue given below. After scrutiny of applications, only those candidates who fulfill the eligibility criteria, will be allowed to appear for Personal Interview. Such selected candidates will have to undergo Pre-Employment Medical Examination, for which they will have to bear the cost, including cost of any additional tests, if required.

 - 2. Educational Qualification
 - 3. State Council Registration
 - 4. Experience
 - 5. 03 passport size photographs
 - 6. Applicable for SC / ST / OBC candidates only: Caste Certificate in the prescribed Proforma issued by the Appropriate Authority. Candidates belonging to OBC category will be required to attach the Caste Certificate in the proforma meant for Central Government Employment and the validity of "Non-Creamy layer" Certificate should not be older than 06 months from the date of Eligibility Criteria.
- iii) Candidates are also required to bring Application Fees in form of Demand Draft for an amount of Rs.500/- (Rupees Five Hundred Only) in favour of "Air India Ltd.", payable at Mumbai as non-refundable application fees.
